Old Business

- 1) Charlie has been working on getting the club to regain their non-profit status
- 2) Charlie has been working with the bank to get everything transferred over to him. We will be having Jim and Frank removed from the bank account and have Brady Anderson and Charlie added.
- 3) Charlie will work with the banks Clover rep to see if it is a better option for processing
- 4) We have changed vendors for buckles for last year and are very hopeful with the new vendor.
- 5) We are accepting preregistration for all shoots by emailing with your name, class and group
- 6) We are accepting credit cards for most shoots now, for those shoots there will be a \$3 cash discount for those choosing to pay via cash instead of by credit card

New Business:

1. Adrian Empire would like to do a land lease, however there are concerns regarding the steel weapons. They were offered to come present to the club, however, a member did not come nor did they respond to the invite.
2. SCA wants to come back once a month to do throwing, proposition will be added to the September board meeting agenda.
3. The floor was opened regarding the bylaws and constitution
 1. The main change was that we are proposing to bring back work points
 2. Initially what was the Tournament Chairman was changed to the Property Manager which has been updated to the Range Master. The range manager would be responsible for pretty much anything and everything at the range from range maintenance to tournaments, to food and beverage. They can form have their own groups to help.
 3. Questioned if the Range Manger is a voted position or an elected position. It was decided that the Range Manger will be changed from a voted position to a elected position by the President who has voting rights on the board.
4. Update: Since with the President voting there would be an even number of votes on the board, the president will not vote on any motions brought to the board or the club instead they will be the tie breaker.
5. Update: The main for of communication including ballots will be electronic and a special request will need to be made 30 days prior to any ballot.
6. Concerns regarding life members needing to earn 12 work points to not be billed unearned work points. Points were made that some life members cant sit for long periods of times or cant drive to the range to help.
 1. Motion was presented to change life members work points from 12 to 6, motion was second. 1 yes 1 no
 2. It was explained that it is listed that points are at the discretion of the board which also include if any special circumstances can be present for review.
7. Update: Sponsoring a new member will earn you points. A new member will be anyone who has never been an LVA member or if they were a prior member who has not been a member for a minimum of 2 years

4. There were concerns regarding the number of members we have in our portfolio and that we should keep inactive members including those who may have passed so when Forest Services asks we can pad our numbers.

1. It was suggested that we should show numbers of how many people show up to a tournament along with an active member count

5. Questions were asked about the Out of State membership. Explained this is for people who live out of state and have an active membership out of state. The membership would have to be verified prior to becoming a member. It was suggested that people will pay the full price and not worry about the out of state membership and to remove it.

1. Motion was made to remove the out of state membership, motion was second. All agree.

2. We currently have no members with an out of state membership, this option will be removed from the new member application

6. Tom would like to have his grandson become a member under his life membership as he previously tried for 2 years to get his grandson a membership as he is a minor and his parents dont shoot.

1. After meeting it was agreed that if his grandson would like a membership and since we offer a juvenile membership he would be able to apply for that.

7. We do not have a date for the Outdoor Championship at this time and we would like to add it to the website. It was decided that the outdoor championship will be held on October 8th

Updates to the Constitution and By-Laws will be updated and approved by the board and will be sent again to the club. Voting on the proposed bylaws and constitution will take place at next month's members meeting.
