We would have never been able to get as much done as we did without you

We have another work party scheduled for Saturday, September 16th starting at 8am. We will be gluing targets and there is a possibility of some light range work.

A proposal for the updated Constitution was presented. Members advised they had some changes they wanted updated.

Junior Board Member:

Request was made to add that the Junior Board member is not able to vote. There was conversation about if the Junior Board member should be considered for an internship which was declined as there is not an employment opportunity,

we would be able to offer them after they have completed their term. The question was asked how long the term for a Junior Board member was advised 6 months with the option to extend for additional terms. Suggested and agreed that since a term is 6 months Junior Board Members should cohost 1 shoot not 2.

Camping Fee:

The question was asked why the camping fee was proposed to be updated to \$15. Kent advised this was discussed at the work party this weekend and there were some good points made and he was going to revisit this. There was a question about how much the power bill is when people camp. Autumn advised historically there is a significant increase in power in March due to Silver Dollar. The decision was made to waive the camping fee for members and have there be a \$10 camping donation per night per vehicle for nonmembers.

Indoor Championship

A proposal was made to remove the option that you can shoot the same style at multiple locations and your highest score would be recorded. A vote was presented to allow members to shoot the same style at multiple locations and the best score is recorded as your final score or if you shoot the same style at multiple locations your first score is recorded. Members will be able to shoot the same style at multiple locations, however, your first score will be the recorded score.

Board Responsibilities

It was suggested to remove that board members must attend 50% of each board meetings, member meetings and special called meetings as people have jobs and families, it was also suggested that board members shouldn't have to host 1 shoot over the course of their year or forfeit their position on the board and must wait 1 year before running for another board or officer position. Both had many disagreements, some being that hosting 1 shoot and not forcing members to host is acceptable, members wanted to raise the number of meetings board members must be present at. It was agreed that board members will need to attend 50% of member, board and specially called meetings as well as to host 1 shoot per membership year during their term. Board members being required to attend 50% of meetings start August 1st. Comments were made about specific board members which Kent had advised he was already planning on addressing concerns with them directly.

Volunteer

Proposed to remove the discounted entry fee for members who help with shoots, and instead offer raffle tickets for members who help which will enter them in a special drawing for just volunteers. Conversations were had that this should be removed completely from the by laws as it is an incentive that the board would like to offer. The board will offer raffle tickets to members who help and volunteer their assistance to better the club. Helping with shoots, helping with work parties, helping in general you will receive raffle tickets that will enter you into a drawing for something awesome. There was concern on how we would be paying for this. Kent advised we do have a raffle budget we will utilize for all raffle items.

Proposal was presented to accept the logo Alejandro created as the new LVA logo and retire the current teepee. All in attendance voted in favor.



Proposal was presented to flighting championship shoot's. Motion was not presented; no members were in favor of flighting championship shoots.

Membership renewals for 2023-2024 went out, if you did not receive yours or if you have questions, please reach out so we can help. Please also note the gate code has changed. If you did not get that please reach out to Melissa so she can verify your membership status and will provide you with the gate code. Please also do not give out the gate code and risk losing your membership. If someone asks for the code, direct them to reach out to Melissa and she will confirm membership and get them the code. (You can reach out to Melissa via email, the LVA phone number, social media messaging)

If you bring your pets up to the range, please make sure you pick after your pets. There has been a lot all over the range.

We added a brag board to the club house. Please feel free to post your pictures. If you have an awesome shot, got an animal, won awards, anything you would like to brag about please put it up there we would love to celebrate your successes and achievements. The board will officially be up in a few weeks.

We are now also currently offering a money shoot only for the Silver Dollar and Safari shoot. Everyone is eligible to enter, it will be a \$50 entry fee. LVA will match up to \$500. There is only one group for money shoot, so kids, adults, seniors, men and women will all compete against each other, all shooters will shoot from the adult stake and will be flighted together. We will follow NBHA's payout which if you would like more information, they have it listed on their website.

Melissa reviewed the current preregistration process. It was proposed to create a google form for a pre-registration in place of emails. (Preregistration form has been linked on the website under calendar, Upcoming Events and in the link tree on Instagram.

We also have water up in the club house fridge and will offer drinks and food at shoots but we do ask for donations so we can continue to offer this.

Unmarked Championship and Fun Shoot: if you shoot the unmarked you get a 50% discount on the fun shoot so come shoot both! Unmarked Championship will be Saturday, September 9th and the Marked 3d will be Sunday, September 10th.

Nevada Senior Games: You will need to register with Nevada Senior Games

NBHA and LVA Outdoor Championship Shoot - We have updated our pricing for this one shoot, and it will be discounted an additional \$10.

All Senior Classes, Adults & Young Adults: Preregistration \$30 / Day of \$40

Youth: Preregistration \$20 / Day of \$30 Cub: Preregistration \$10 / Day of \$20

Pee Wee: Free

Because we are partnering with NBHA you must register with NBHA to be able to register with LVA to shoot. Entry fee for NBHA is \$45. If you would like to shoot it as a money shoot with them you do need a NFAA membership and an additional \$50 entry fee. If you do not want to do the money shoot side of it you can register as a guest with them.

When you pre-register for the LVA please note that we do not offer refunds. That means if you pre-register and we cannot verify that you registered with NBHA you will not receive a refund.

If you would like to help with any shoots please let us know. Some areas we can use help with:

Setting up and taking down targets & drink stations

Getting food ready while everyone is out shooting

Indoor Championships will now be the 2nd, 3rd, and 4th weekends in January moving forward (specific dates and times will be determined by the shops).

Silver Dollar shoots will now be the 2nd to last weekend in March moving forward.
