### **Floor Opened to Members:**

NBHA has agreed to host their annual shoot October 14<sup>th</sup> at LVA and we will be doing a dual shoot with LVA's Outdoor Championship. If you want to just shoot the NBHA Outdoor Championship you can do that, but if you want to shoot the LVA Outdoor Championship as well you will have to sign up for both and there will be a dual entry fee for both NBHA and LVA.

There is a bunch of work needed on the practice range, but with the snow we have not been able to do anything. We are aware of the 20 yrd target down and as the bails are extremely heavy we need a group of people to help put it back up. When the weather is a bit better we will host a work party.

Question was asked if memberships are raised are work points going to be reviewed. Brady explained work points were never ment to bring in income but to bring in volunteers. At this time we are not looking to change the membership pricing especially since the Forrest Services lowered the expected lease fee.

We are still working with the Forrest Services on inventorying everything at the range, maintenance plans. If there are any updates to the club or repairs please email in so we can add those to the plans.

If there is anything you would like changed, updated, looked into for the club please let us know. If you go to another shoot and they do something you like let us know. If you are at a shoot and you like or dislike something let us know. We want this to be a club for everyone that everyone enjoys and we need your help and suggestions to be able to do that.

It was questioned about getting an areaial view of the range. We had a member that had a drone but there was some drone issues and we have not been able to get that. If you know someone who would like to or could let us know so we can help set that up.

Brady explained that if we cut down the range in any way we wont be able to ever get that land back. There was prior talk of giving up the land we use for the 3d course, that was a discussion but he does not want to cut down land currently being used. We do and are still working on getting membership trends to see if we can afford our current full acreage which is based off the GPS of the Forrest Services.
